Corporate Citizenship Defined

What the experts say...

Association of Corporate Citizen Professionals defines it as an integral function within the corporate structure supporting programs that can shape the public image of a company and influence corporate culture within a company.

Boston College Center for Corporate Citizenship defines corporate citizenship as how a company exercises its rights, obligations, privileges, and overall corporate responsibility within our local and global environments.

CSRwire defines it as the integration of business operations and values, whereby the interests of all stakeholders including investors, customers, employees, the community and the environment are reflected in the company's policies and actions.

Business Impact



Engaged organizations have 22% higher profitability and 10% higher customer rating than peers.



Employees who say they can make an impact while on the job report higher levels of job satisfaction than those who can't by a 2:1 ratio.

Net Impact "What Workers Want" 2012



Employees who derive meaning and significance from their work were more than 3 times as likely to stay with their organizations.

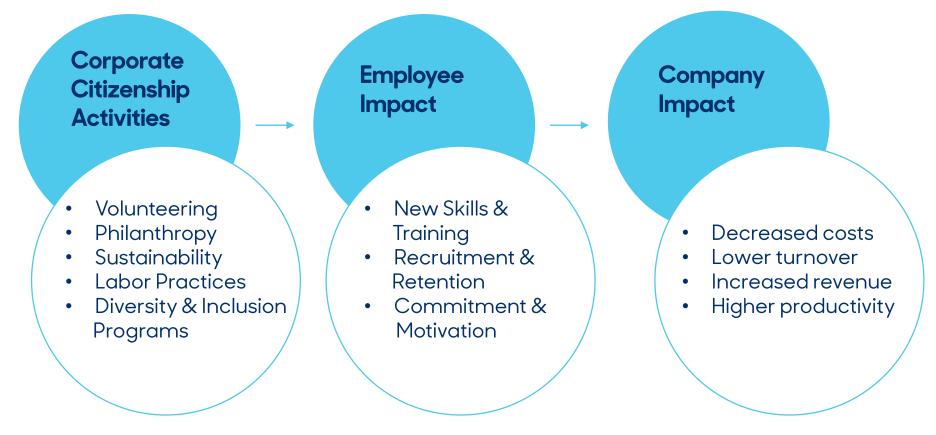
